# INDIAN ECONOMIC SERVICE / INDIAN STATISTICAL SERVICE EXAMINATION, 2025

Based on the results of the written examination of the Indian Economic Service / Indian Statistical Service Examination, 2025 held by the UNION PUBLIC SERVICE COMMISSION from 20th to 22nd June, 2025 followed by interviews for Personality Test in September, 2025, the lists, in order of merit, of the candidates who have been recommended for appointment to the posts in Indian Economic Service and Indian Statistical Service are attached as Annexure I & II.
