Subject: - Notice to declare Result for Physical Endurance Test (PET) held on 09.06.2025 and 10.06.2025 and calling of E-dossiers for the Post of Matron (Reserved for Female Only) under post code 112/23 in Delhi Prisons.

- 1. The DSSSB vide its advertisement no. 03/23 with closing date 20/12/2023 had advertised Total 62 vacancies (UR-13, EWS-02, OBC-27, SC-17, ST-03, Including ExSM-06 & Sports Person-03) for the Post of Matron (Reserved for Female only) under Post Code-112/23 in Delhi Prisons and the written examination (online mode) Tier-I for recruitment in respect of this post was conducted on 07th July, 2024 & 13th July, 2024.
- 2. On qualifying written examination (online mode), vide Notice No. 258 dated 21/11/2024 and Corrigendum dated 07/03/2025, the DSSSB shortlisted 653 candidates for appearing in Physical Endurance Test (PET) for the post of Matron (Reserved for Female Only) under Post Code-112/23 in Delhi Prisons.
- 3. The PET (Physical Endurance Test) for Race, Long Jump, High jump was scheduled on 09.06.2025 & 10.06.2025, wherein out of 653 candidates 399 candidates appeared for the test. Only 271 candidates could qualify in PET (Physical Endurance Test) held on 09.06.2025 and 10.06.2025. DSSSB has decided that the Physical Standard Measurement (Height & Chest) and checking for any defect or deformity (including bow-legged, knock-knees, flat feet, etc.) of candidates will be conducted by the User Department after providing dossiers.

The candidate bearing roll no. 9110000226 is senior in age hence is placed higher in Merit and shortlisted as per Addendum to the Advertisement no. 03/23 dated 27.5.2024 and accordingly other Candidate bearing roll no. 9110000316 is not shortlisted for calling of e-dossier.

- The shortlisted candidates for the above-mentioned post/post code are hereby informed 6. Educational documents up-load all the e-dossier and sheets/Caste Certificates/Degree Marks and Certificate/Professional/Experience Certificate/Proof of Govt. Servant/Ex Servicemen/Sports person Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in PET/skill test.
- 7. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given above.

- 8. All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- 9. The e-dossier link shall be active from <u>25.07.2025 to 08.08.2025</u>. The candidate uploading e-dossier should ensure that she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., <u>20/12/2023</u>.
- 10. The above shortlisted candidates are also being separately informed through SMS and email on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 11. All the candidates who have been shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. 25.07.2025 to 08.08.2025.
- 12. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon his/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above, she will not be given any further opportunity and his candidature will be treated as cancelled.
- 13. The above short listing of candidates for calling of e-dossier for the post code -112/23 will be subject to outcome of pending court cases, if any.
